

**CANTONMENT BOARD, SHAHJAHANPUR**  
**PUBLIC NOTICE OF ELECTION**  
**(Under Rule 20 of the Cantonment electoral Rules 2007)**

Whereas the Central Government in exercise of powers conferred under Section 15(1) of the Cantonment Act 2006, has vide gazette Notification SRO 03(E) dated 17.02.2023 notified 30<sup>th</sup> April 2023 as the date on which election to Cantonment Board Shahjahanpur shall be held.

Now the Cantonment Board, Shahjahanpur in pursuance of the said gazette notification SRO 03(E) dated 17.02.2023 of Central Government under the provision of Rule 20 of the Cantonment Electoral Rules 2007 sets out the following:-

- (I) The Election Program, inter alia specifying the date, time and places of polling, the time and place for receipt of nominations, the time and place for scrutiny of nominations and other matters considered by the Board to be necessary for information and assistance of voters and candidates is as under :-

- (III) The symbols that may be chosen by the candidate and the restriction to which their choice shall be subjected shall be in accordance with the Electoral Symbols (Reservation and Allotment) Order, 1968 of the Election Commission of India as modified from time to time till date and the Notification of the Election Commission of India issued in pursuance of the said orders as amended from time to time till date, and the allotment of symbols by the Returning Officer shall be governed by the provision Rule 31(4 and 5) of the Cantonment Electoral Rules 2007. The allotment of the symbols by the Returning Officer to a candidate shall be final. Reserved Symbols for National/State recognized political party can be allotted by Returning Officer only. If candidates are duly sponsored by the political parties concerned. The said sponsorship/authorization should be in conformity with Election Commission of India guidelines and shall be duly signed by the President or the Secretary or any/authorized office bearer of the party, and the President, Secretary or such other authorized office bearer sending the said sponsorship should be duly authorized by the party. **List of Symbol is attached as appendix "A"**

- (IV) **The number of persons to be elected and details of wards reserved for scheduled caste / schedule Tribes and Women is as under:**



- (V) The nomination papers will be presented to the Returning Officer at the Cantonment Board Office on the date and time fixed above.
- (VI) Attention of the public is invited to the Cantonment Electoral Rules, 2007, which govern the election of the members to the Board. Copies of the Rules are not available for sale but may be obtained from the Publication branch, Govt. of India, Delhi on payment. However the same can be seen in the Cantonment Board Office.
- (VII) Only the nominees, their duly authorized election agents and their proposers may be present at the time of the scrutiny of nomination papers and objections by the Returning Officer on the date, time and place mentioned above.

(VIII) Nomination form (form VI) may be obtained from the office of the Cantonment Board during working hours on any working day. Form of application for inclusion of names in the Electoral Rolls and application for objection to any entry can also be obtained from the office of the Board during the time prescribed above.

(IX) Each candidate with his nomination paper shall deposit, or cause to be deposited with the Returning Officer a sum of Rs. 3000/- (Rupees Three thousand only) in Cash. Provided that where the candidate belongs to the Schedule Caste or Schedule Tribes, the amount of such deposit shall be Rs. 1500/- (Rupees One thousand five hundred only) Provided that where more than one nomination paper is prescribed, one deposit only shall be sufficient.
